DIRECTIONS FOR RE-ENROLLING STUDENTS:

1. Read all information below before completing registration.

Policy: Tuition, Fees and EXCEL must be current for In-House Packets to be processed.

2. Additional siblings beginning school next year may be added on the re-enrollment form.

If you have additional siblings we will need copies of the following:

Birth Certificate
Baptismal Certificate
First Communion Certificate (if applicable)
Immunization Records
Social Security Card
Most Recent Report Card (for students in grades 1-8)

3. **The printed re-enrollment form must be signed and returned, along with your non-refundable registration payment, for re-enrollment to be processed and completed.**

By signing this Re-Enrollment form you are agreeing to abide by all RCE Policies, including discipline consequences and uniform requirements. You are also agreeing to positively promote RCE and take part in Parent Meetings.

Tuition

Subsidy

Member of St. Joseph Parish=\$75 per student

Catholic Non-Member of St. Joseph Parish=\$100 per student

Non-Catholic=\$125 per student

Families whose Church Parish does not pay the subsidy will assume responsibility for payment. The subsidy billing will occur in the month of December for those who did not list a Church Parish on their registration papers or for those whose Church Parish declined to pay the subsidy for the family.

Fees: All fees are mandatory and non-refundable.

Family Fee \$430

- \$280 Capital Improvement Fee (note for the Junior High Wing)
- \$100 Building Improvement Fee
- \$50 Home and School Auction Fee (2 Auction Entrance Tickets)
Student will NOT be allowed to attend classes until fee is paid.

Student Fee \$190

- \$65 Technology Fee for Hardware, Software and Memberships
- \$50 Textbook Fee for student textbooks
- \$30 Testing Fee for ACT Aspire Test, DIBELS Test and AR Test
- \$30 Student Supply Fee (\$20 General, \$5 Science Lab, and \$5 Art Supplies)
- \$15 Home and School Fee for Class Auction Basket
Student will NOT be allowed to attend classes until fee is paid.

Per Grade Fees:

- 8th Grade: \$40 Buddy Program Fee (billed with August tuition)
\$40 Graduation Fee (billed with April tuition)
- Kindergarten: \$40 Buddy Program (billed with August tuition)

Tuition Assistance: Family must be registered to apply for assistance.

Anyone interested in applying for tuition assistance may do so one of two ways:

- 1.) Contacting your church parish about the possibility of receiving assistance. Many church parishes have their own assistance programs. (St. Joseph Parish's program goes through the school.)
- 2.) Complete a RCE tuition assistance packet, which can be requested from the school office after completing registration. **For consideration, all forms must be completed and returned to the school's office by April 17, 2019.** Tuition assistance does not automatically carry over from year to year. Families must reapply each year.

Delinquent Tuition Policy:

Monthly tuition payments are due in full on the first school day of each month and are considered delinquent after the 10th of each month. Delinquent policies, as stated in the school handbook, apply.
